## **Minutes**

- 1. Call to Order: 6:00 P.M.
- 2. Roll Call: Mr. Eucalitto, Mr. Maniccia, Mr. Corey (Remote), Ms. Mangan (Teacher Representative)

- 3. Approval of Agenda: Mr. Maniccia made a motion to approve the minutes, second by Mr. Corey. All in favor.
- 4. Approval of Minutes: Mr. Maniccia made a motion to approve the minutes with the date change to March 3<sup>rd</sup>, 2021, second by Mr. Corey. All in favor.
- 5. Public Participation: None
- 6. Discussion/Next Steps:
  - a. Security Grant Update The State has specific guidance on what districts must follow in their application. Discussion of the grant and possibilities will continue next month.
  - b. Window Project Update The State wants us to resubmit our paperwork all at once on May 1<sup>st</sup>. We will not be able to start the project this summer.
  - c. Field Usage The City is billing the district \$200 per baseball game to use Fuessenich Park. The TMS fields need work right now. We need to have a discussion of how we should proceed. Ms. Cappabianca stated that the Board should write a letter to the City Council and the Mayor to see if there could be a waiver on district field use. We do not charge the city when they use our buildings. We can still pay a staff fee if needed. The Committee recommends that the Board to write a letter to the City regarding the payment for the use of fields. This will be discussed at the next Board meeting. Mr. Barlow described the

improvements needed for the TMS field. Mr. Eucalitto wants the Board to inquire if the City would allow a long-term lease to use Fuessenich Park for varsity games. Mr. Barlow will consult on the ways to improve the quality of the TMS fields, so they could become shared facilities for practices.

- d. Alliance Construction Grant Update:
  - 1.Stair Treads Vogel-Wetmore Completed.
  - 2.Ceiling Tile Project Middle School The two classroom wings are completed, and the rest will be completed in June.
  - 3.Refinishing Gym Floor Middle School / Vogel-Wetmore Start date is June 22, 2021.
- e. Technology Update: The district has upgraded the power systems to enable us to sustain power of all systems until the generator kicks in in the event of an outage. Ms. Herold shared that her team went through all the data backup and updated all our systems.

  - 1.Develop a plan to re-align TPS facility needs once the new building opens. Ms. Cappabianca stated that it would be a good idea for this committee to look at the data that already exists for capacity.
