Minutes

- 1. Call to Order: 7:51 P.M.
- 1. Roll Call: Ms. Hoehne, Ms. Richardson, Ms. Todor, Ms. DePretis, Mr. Mangelinkx (Teacher Representative)
 - Also Present: Ms. Cappabianca, Mr. Kissko, Ms. Lubomski, Ms. Fergusson, Ms. Schulte, Ms. Herold, Ms. Klimaszewski
- 2. Approval of Agenda: Ms. Todor made a motion to amend to remove "special" from the title, second by Ms. DePretis. All in favor.
- 3. Approval of Minutes: Ms. DePretis made a motion to amend the minutes to add Mr. Mangelinkx to the roll call list, second by Ms. Todor. All in favor.
- 4. Public Participation: None
- 5. Discussion/Next Steps:
 - a. Health Services #6100 There have been changes to the law which require us to update this policy. The committee must decide if they want to go with one policy or two policies. The committee agreed with two policies. The committee discussed the new religious exemption law that was passed and decided they will discuss that at a later time when the State puts this law into effect. The committee decided to pass the following policies to the full BOE with the appropriate formatting: Shipman Model Policy: Health Assessment Screenings and Shipman Model Policy: Immunizations
 - b. Roles and Responsibilities of Committees #1028 BOE ByLaws
 Ms. Fergusson started the discussion by prefacing that Shipman and CABE do not
 have a policy like this one. Most districts do not have this type of policy because
 the Board By-Laws dictate how committees are handled. The committee
 discussed whether to keep, revise, or eliminate this policy. Ms. Richardson stated
 that the spirit of this policy has district-wide impact and should be kept. Ms.
 Cappabianca asked how do we ensure that this policy is being followed? The
 attorney stated that we do not need this policy. The committee discussed policy
 vs. procedure. Ms. Cappabianca stated that if the committee decides to have this

policy then is has to be clear: What is the district committee? What is the expectation? Ms. Hoehne wants to do away with this policy and see a procedure go into the staff handbook. The committee took a straw poll and 4 of 5 members voted to bring this policy to the full BOE with the recommendation to strike it from the manual.
