- 6. Discussion and Next Steps
 - a. School Improvement Plan: High School The high school administrative team presented the school improvement plan which was a collaboration between OTL, Central Office and the high school administrators. The school's mission statement is to ensure we are a community of motivated, responsible, respectful, and hardworking individuals who value hard work, resiliency, and integrity.
 Priority Goal 1: Cultivate a professional learning environment for teachers that assists them in purposeful and intentional planning that will improve student outcomes. Objective increase the percentage of students performing at the proficient level in reading and math as measured by the Star universal screener.
 Priority Goal 2: Strengthen multi-tiered student support systems to ensure that academic and behavioral decisions and actions are data-driven and responsive to individual student needs. Objective 1 Reduce the percentage of students receiving special education services from 18% at the beginning of 2020-2021 school year to 17% by the end of the 2020-2021 school year. Objective 2-increase the graduation rate from 87.5% in June 2019 to 88.9% by June 2021.

Priority Goal 3: Ensure a culture of caring that supports the improvements of student attendance. Objective – monitor and address chronic absenteeism and lack of student engagement resulting from the pandemic.

Priority Goal 4: Engage in curriculum development and revision to enhance the district's core educational program that ensures equitable access for all learners. Objective – produce revised curriculum documents for courses in the English Language Arts and Social Studies departments.

Ms. Ledversis and her team elaborated in detail to the board how they plan on achieving these goals. This is a living document that will be brought to SIC every year.

- b. Systemwide Focus Areas: These will be addressed through site improvement plans by each school.
 - (Attendance, Student Engagement, Targeting Student Needs)
- c. Delegated SIC Board Goals:
 - 1.(shared with full Board) Monitor the implementation of the district strategic plan and its integration into the city strategic plan once that plan is developed.
 - 2.Monitor and support the Middle School/High School Building Committee and allocate resources to the development and implementation of the "Pathways" approach to the secondary curriculum.
 - 3.Oversee and support whatever is necessary to deal with the educational impact of the effects of prolonged distance learning.
- d. Review of Student Assessment Data: Ms. Fergusson, Mr. Deacon and Ms. Mazzatto tried to capture how our students were doing pre Covid-19 and where the kids are right now according to the STAR assessment. The board reviewed graphs that represented this data.
- e. Report: February 16th Professional Development: Reconvene the Grading Committee to review the survey data. It was evident from the data that the shutdown has had an impact. The only subgroup that did not lose ground is students with disabilities. This is the only group for whom services were not disrupted. Mr. Eucalitto asked that the Grading Committee look at the importance of homework, testing and grading and the outcomes. We are trying to be aware of the barriers our students face right now during Covid-19, and how we can support them so they can reach those high expectations. Ms. Cappabianca stated that there needs to be consistent standards across the board.

- g. Distinguished Alumnus Update: Nomination Process, Medium for Presentation: We have received only one nomination to date. Mrs. Fergusson will send out another press release.
