- 4. Approval of Agenda: Mr. Kissko made the motion to approve the agenda, Mr. Maniccia second. All in favor.
- 5. New Board Members:
  - A. Introduction and Appointment of New Board Members: Mr. Eucalitto is a Democrat. Ms. Todor is a Republican.
  - B. Action Items:
    - 1. Appointment of Democratic Nominee: Ms. Richardson made the motion to appoint Mr. Eucalitto, Mr. Maniccia Second. All in favor.
    - 2. Appointment of Republican Nominee: Mr. Kissko made the motion to appoint Ms. Todor, Mr. Maniccia second. All in favor.
  - C. Swearing in of New Board Members: Mr. Eucalitto was sworn in by Ms. Hoehne. Swearing in of Ms. Todor will happen at a later date.
- 6. Recognitions: Ms. Lubomski and Ms. Cappabianca awarded recognition plaques and certificates to recipients.
- 7. School/Community Service/Public Participation:
  - Mr. Michael Conway of Torrington spoke to encourage the Board of Education to permanently appoint Interim Superintendent and Interim Assistant Superintendent to the positions as they have many years invested in the Torrington Public School system.
- 8. Information Sharing Session:
  - A. Superintendent's Report: In spite of the early release days because of the extreme heat, there was a great beginning to the new school year. Convocation was motivating and inspiring. "Together we are Stronger" is the message for the new year. Elementary schools are all adjusting to the new sister school redistricting model. TMS will be hosting the Chinese delegation next week. There is a hope for an exchange of teachers between the two countries. The NEASC will occur May 5 9, 2019 at THS. Compliments to Mr. Splettstoeszer, THS Band and Music Teacher, for being recognized as a role model teacher, band leader, presenter and website/resource media exemplar at the Music Conference in Boston as well as for the THS Marching Band for earning 1<sup>ST</sup> place in the Bristol Mum Festival. TPS received a huge donation from local Walmart of multiple carriages of school supplies. AllStar Bus Company has been willing to store these items,

- so the district can use them as needed. Many thanks to all the Central Office Team for their hard-work and dedication during these times of transition.
- B. Assistant Superintendent Report: A detailed overview of the SAT/SBAC scores was presented. There were significant gains in 8<sup>th</sup> grade in ELA and Math. Scores were presented from a variety of perspectives including "historical, cohort, and subgroups." Torrington's performance was also shown compared to other districts in our DRG as well as other Alliance Districts. One reason for wavering math scores is the numerous change in instructional programs. Currently, we are using the Bridges resource at the elementary level and Open Up Math in grades 6,7,8. We are confident fidelity of instructional strategy and consistency of programming will strengthen our students' math performance.
- C. Monthly Financials: Some line items have overages; however, most items are encumbered, so they appear that they are over budget, but they are not.
- D. Budget Transfers: Items presented.
- E. Capital Projects: Mr. Bascetta discussed the RFP for the Underground Storage Treatment. The Ground Permit expires 10/31/18. The removal is time sensitive, testing has been done for the removal of the tank and possible ground contamination. The testing did not find any contamination. The environmental testing completed in October 2017 will expire soon. The tree removal of a rotted tree at Vogel-Wetmore was completed.
- F. Grants: K-1 Primary Mental Health which supports school acclimation; The Workforce Innovation and Opportunity Grant (Promoted by the Mayor's Office) is an initiative to assist 16-21 year olds' transition into jobs.
- G. Mr. Kissko made a motion to enter into Executive Session, Ms. Hoehne second. All in favor. The Board went into Executive Session at 7:46PM.
