- 1. Call to Order: 6:03 P.M.

 - a. Security Grant Update There is \$4.5 million dollars in the grant that will be split between 169 districts.  - b. Window Project Update All paperwork has been submitted to the state. A meeting with the state will be scheduled for some time in June.
 - c. Update of Items on Capital Plan 2022-2023: Mr. Barlow started preliminary proposals for the updated Capital Plan 2022-2023. These included some security items. Mr. Barlow stated that he is working on the 10-year Capital Plan.
 - d. Executive Session on Security: Mr. Corey made a motion to go into executive session inviting in everyone on the board, Ms. Mangan, the board clerk, Ms. Lubomski, Mr. Barlow, Mr. Arum and Ms. Herold, second by Ms. Fappiano. All in favor.
