#### Minutes

- 1. Call to Order: 6:00PM
- 2. Pledge of Allegiance

- 4. Approval of Agenda: Ms. Hoehne made a motion to amend the agenda adding 8F Music Trip and 10J Music Trip, Ms. Spino second. All in favor.
- 5. Recognitions: Ms. Lubomski and Ms. Hoehne passed out certificates to students and staff for various achievements. There was a PowerPoint of paintings and art that were done at the Torrington public schools. There was a PowerPoint of the Fitness Trail installation at TMS.
- 6. School/Community Service/Public Participation: Student Representative, Julia McCarthy reported on THS events: August 2<sup>nd</sup> teachers and students cleaned up THS, August 23 incoming freshmen and new students will be coming to THS for presentation, THS Band has been preparing for the upcoming school year and August 26 there will be a Fall Sports meeting.

  - A. Superintendent's Report: Ms. Lubomski reported that a busy summer. She thanked the custodians, administrators, secretaries and central office personnel. She also thanked the staff who participated in curriculum work. There was a meet and greet on August 10<sup>th</sup> over 400 backpacks were given out and there were 450 participants. Thank the board for the support of our new position, I believe that this will make all of the difference.
  - B. End of Year Financials 2018-2019: Mr. Arum reported that we ended up with a surplus of about \$15,000. Thank you to everyone and our venders.
  - C. Policy #4081 Abuse/Neglect of Disabled Adults (New): Ms. Hoehne reported that this was a policy we did not have and needed. IT was reviewed comprehensively in Policy.
  - D. Policy #4006A Employment Check Policy (Update): Ms. Hoehne reported that this policy is not updated with the new regulations.
  - E. Policy #4082 Reports of Suspected Abuse or Neglect of Children or Sexual Assault of Students by School Employees (New): Ms. Hoehne reported that we did not have this policy and it was reviewed comprehensively in Policy.
  - F. Music Field Trip: Big E on September 9 Paperwork was passed out for this annual field trip.
